WHEREAS the Board of Commissioners of Hardwick Electric Department is aware that the Plan(s) must periodically be amended to comply with new or changed regulations, rulings, legislation and plan operations, and that this restatement will be effective as of July 1, 2022.

THEREFORE BE IT RESOLVED that this Board authorizes the July 1, 2022 amendment, restatement and continuance of the Plan to conform in its entirety with all the provisions of the governing plan document of the Plan, through the execution of the Adoption Agreement attached hereto, which includes all of the provisions of the entity's most recently executed Adoption Agreement and any compliance clarifications needed to conform with plan operations; and

BE IT FURTHER RESOLVED, in the event that the timing of the restatement does not correspond with regularly scheduled meetings of the Board of Commissioners, the Board does hereby authorize and direct the participating employer's authorized representative to execute all necessary documents and to take any and all further actions necessary to carry out the July 1, 2022 amendment and restatement of the Plan; and, NRECA is fully authorized to rely on this designation in processing the restatement of the Plan.
